## 2019 STUDENT OUTCOMES

To help the community during their decision-making process, we are sharing the following outcome rates and other school information as reported to our accrediting agency, the State of California, and the U.S. Department of Education, respectively, for students scheduled to graduate during the year 2019.

Exclusions are graduates that have died, became incarcerated, were called in to active military duty, were international students that left the United States or did not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
